hereby declare under oath as follows:

1. I have deposed to an affidavit dated 13 May 2019 (the "main affidavit"), setting out my knowledge relating to the events which relate to a transaction in terms of which 2000 minutes' worth of archive footage was provided by the SABC to Infinity Media
2. I depose to this supplementary affidavit to include matters I did not raise or deal with in my main affidavit.

4. In paragraph 6 of my main affidavit, I mentioned that I sat with Mr Rahul perusing archive footage and making a copy of the relevant portions of the archive footage he required.

6. I recall spending more or less 3 weeks copying the footage onto the tapes provided.

7. I don't recall the exact amount of footage transferred but I'm thinking around 8 to 10 two hour tapes were used to copy the footage onto.


