**MS DUDUZILE CYNTHIA MYENI // JUDICIAL COMMISSION OF INQUIRY INTO
ALLEGATION OF STATE CAPTURE, CORRUPTION AND FRAUD IN THE PUBLIC
SECTION INCLUDING ORGANS OF STATE**

1. This letter is addressed to you by the Commission from its Eskom workstream, on the understanding, from your letter to the Commission dated 5 August 2020, that your law firm has been appointed to represent Ms Duduzile Myeni ("Ms Myeni") and placed itself on record accordingly with the Commission.
2. The Eskom workstream wishes to obtain an affidavit or statement from Ms Duduzile Myeni in regard to what the Commission has been informed was her

involvement in meetings, together with Mr Jacob Zuma, where, *inter alia*, the suspension of certain Eskom senior executives was planned and discussed.

3. To that end, Ms Myeni is hereby requested to deliver on or before **Friday, 4 September 2020**, to the Commission at the email addresses provided above, an affidavit, affirmed declaration or statement in which-
 - 3.1. she states whether she admits or denies the allegations made about or against her in the following:
 - 3.1.1. a statement of **Mr Nicholas Hugh Linnell** dated **21 November 2017**, a copy of which annexed hereto marked "**E1**";
 - 3.1.2. an affidavit of **Mr Nicholas Hugh Linnell** dated **9 March 2018**, a copy of which is annexed hereto marked "**E2**";
 - 3.1.3. an affidavit of **Mr Andile Zola Tsotsi** dated 13 February 2020, a copy of which is annexed hereto marked "**E3**".
 - 3.2. if she denies or disputes any allegation or statement made about or against her in the said statement and affidavits, she is required to state the grounds on which she relies for her denial and give her full version in regard to the allegations or statements or issues or matters or incidents covered therein insofar as they refer and/or relate to her.
4. Ms Myeni is requested to advise the Commission, **within three (3) calendar days** of receipt hereof, i.e. no later than **20 August 2020**, whether she undertakes to furnish the Commission with an affidavit, affirmed declaration or statement within the stipulated time. Her failure to do so, will be construed by the Commission as an intention on her part not to furnish the required affidavit, affirmed declaration or statement.
5. Your co-operation will be highly appreciated.
