2. The contents of this affidavit fall within my personal knowledge unless otherwise stated or the context indicates the contrary and are both true and correct.



3. On Friday, 2 October 2020 I testified before the honourable Mr Justice Zondo, the chairperson of the Judicial Commission of Enquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State ("the Commission").
4. Before I started my evidence, counsel representing me pointed out to the Chairperson that there was a mistake in paragraph 12 of my affidavit dated 29 April 2019, which served before the Commission as Exhibit "T17.3". Paragraph 12 appears on page 32 of Exhibit "T17".
5. The mistake concerns the last two words in the paragraph "the EPRU", which should have read "Bosasa". The last sentence in paragraph 12 should accordingly read as follows: "Travel arrangements were managed by the EPRU office and I only subsequently learnt, in a discussion with Cheeky Watson during Mr Agrizzi's evidence, that Blakes Travel was the travel service provider to Bosasa".
6. The Chairperson requested that I file an affidavit to correct that mistake, hence this affidavit.
7. I have also picked up a typographical error in my affidavit which I signed on 3 September 2019 and which served before the Commission as Exhibit "T17.4". In paragraph 14.3 thereof, which appears on page 63 of Exhibit "T17", the last sentence reads "I again repeat that these

allegations are devoid of any proof". It should have read "I again repeat that these allegations are devoid of any truth".


8. I unfortunately did not pick up these two mistakes when I read through the two affidavits before I signed them.
